In terms of the Minerals and Petroleum Resources Development Act (MPRDA), Sasol Mining (Proprietary) Limited has an approved social labour plan that is aligned to the integrated development plan (IDP) of Dipaleseng Local Municipality.

Sasol Mining has embarked on an extensive consultative process with the Dipaleseng Local Municipality to identify and agree upon suitable local economic development (LED) projects. Projects were identified and discussed by a working committee specifically created for this purpose. The working committee comprised of representatives from the municipality and Sasol Mining. The SLP LED projects include proposals from Dipaleseng Local Municipality and are contained in the regional IDP.


